1<sup>st</sup> RACE An objection was lodged by the rider of eighth place #8 "Alotmoreaction" (Rocco Bowen) alleging interference by the rider of second place #3 "Kiss Mo" (Declan Cannon) leaving the 1/8 pole. After reviewing the race replay and interviewing the riders, including third place #11 "Headline Kitten" (Angel Serpa) the stewards determined that #11 came in and forced #3 into #8, causing #8 to steady sharply and lose momentum. For the interference #11 was disqualified from third and placed eighth behind #8.
