An objection was lodged by the rider of second place #4 "Tami Ann" (Luan Machado) alleging interference by the rider of the unofficial winner #12 "Neversynoletsgo" (Sonny Leon) approaching the finish. After reviewing the race replay and interviewing the riders, the stewards determined that #12 ducked in nearing the finish and caused #4 to alter course, but that the incident occurred late in the race and did not impact the order of finish. There was no change in the original order of finish and the race was posted official.

The claim of #2 "Super Lucy" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
