1<sup>st</sup> RACE #2 "Redneck Agenda" (German Terraza) was pulled up near the 3/8 pole and required the assistance of the KHRC veterinarian and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

4<sup>th</sup> RACE Voided claim - no race number

5<sup>th</sup> RACE Irving Moncada rode #11 "Better Justice", his first probationary mount.

6<sup>th</sup> RACE A Stewards Inquiry was posted involving the stretch and, in addition, an objection was lodged by the rider of fourth place #1 "Counterstrike" (Adam Beschizza) alleging interference by the rider of the unofficial winner #5 "Antares" (Gerardo Corrales). After reviewing the race replay and interviewing the riders, the stewards determined that #5 angled out in the stretch, causing #1 on his outside to check sharply and lose momentum. For the interference #5 was disqualified from first and placed fourth, behind #1. Official order of finish: 8-3-1-5
