7th RACE A Stewards Inquiry was posted involving the stretch and, in addition, an objection was lodged by the rider of second place #11 "Liliesformillie" (Jack Gilligan) alleging interference by the rider of the unofficial winner #9 "B G Warrior" (David Haldar) in the stretch. After reviewing the race replay and interviewing the riders the stewards determined that #9 bore out repeatedly in the stretch, making contact with #11 and impeding her progress. For the interference #9 was disqualified from first and placed second, behind #11. Official order of finish: 11-9-1-5
