3<sup>rd</sup> RACE An objection was lodged by the rider of second place #7 "Dragon Drew" (Albin Jimenez) alleging interference by the rider of the unofficial winner #5 "Dom the Bomb" (Gerardo Corrales) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #5 drifted in and caused #7 to check sharply and lose momentum. For the interference, #5 was disqualified and placed second, behind #7.

4<sup>th</sup> RACE Voided claim - no owner listed

A Stewards' Inquiry was posted involving the start of #5 "Goldenpence" (Edgar Morales). After reviewing the race replay and interviewing the starter, the stewards determined that the horse was not precluded from obtaining a fair start and was dispatched with the rest of the field. There was no action taken and the race was posted official.

5<sup>th</sup> RACE CLEAR  
 6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE #6 "Hazel Rah" (Joseph Ramos) broke through the gate prior to the start, but the assistant starter expertly held the horse in place and the rider stayed aboard. The door was closed and the start was without incident.

#3 "Souper Highvoltage" (Luan Machado) set a New Track Record of 1:15:18 for 6-1/2 furlongs

8<sup>th</sup> RACE #4 "Engrave" (Chris Landeros) stopped badly in the stretch, walked across the finish line well behind the field and left the track on his own power. The horse was placed on the Stewards' List.
