1st RACE CLEAR

2nd RACE #4 "Pour It Neat" (Martin Garcia) trailed the field, was pulled up near the 1/8 pole, and left the track on his own power.

3rd RACE CLEAR

5th RACE CLEAR

6th RACE #9 "Juradical" (Oscar Villarreal) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian.

#7 "Broadway Blaze" (Joseph Talamo) broke through the gate prior to the start but the rider stayed aboard. The horse was reloaded and the start was without incident.

7th RACE #6 "Whenthe dawn breaks" flipped in the paddock and was a late scratch on the advice of the KHRC veterinarian. As this was the second time for being fractious and scratched in the paddock, the filly was placed on the Stewards list and the Paddock Judge list.

8th RACE CLEAR

9th RACE #2 "Meet You Now" (Yarmarie Correa) unseated his rider behind the starting gate and ran loose, evading the outriders. The horse was scratched by the stewards and was eventually caught by the outriders and escorted off the track.
