4<sup>th</sup> RACE A Stewards Inquiry was posted involving the start of #11 "Speed Warning" (Julio Felix) who finished fourth. After reviewing the race replay and interviewing the starter and rider, the stewards determined that the horse lunged forward and hit the front doors of the starting gate as they were opening and did not break ahead of the field. After confirming that there was no advantage gained by the horse, there was no action taken and the race was posted official.
