#7 "Uncle Headley" (Gerardo Corrales) was a late scratch from the post parade on the advice of the KHRC veterinarian. Three claims that had been submitted for the horse were voided.

4<sup>th</sup> RACE #8 "Adalinda" (Joe Musarro) BLED, was eased, and required the assistance of the KHRC veterinarians and the horse ambulance. The horse was placed on the See State Vet list.

5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE #6 "Praise and Honor" (Joseph Rocco, Jr.) broke through the gate prior to the start, unseated the rider and escaped from the assistant starter despite his valiant attempt to hold her in place. Rocco was injured in the incident. The outriders quickly caught the loose horse, who was returned to the paddock for a substitute rider. During the 15 minute delay, the jockeys dismounted and the horses were kept behind the starting gate.

7<sup>th</sup> RACE #5 "Argentello (IRE)" (Jane Elliott) was a late scratch from the post parade on the advice of the KHRC veterinarian.

8<sup>th</sup> RACE #13 "Off the Cuff" (Gerardo Corrales) unseated his rider behind the starting gate and ran loose, evading the outriders until he was scratched by the stewards. Corrales escaped injury.
