Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, the sample taken from INFINITY OF HUMOR who finished first in the seventh race at Churchill Downs on November 26, 2014 contained the acepromazine metabolite HEPS (Class B drug). INFINITY OF HUMOR is disqualified and all purse money forfeited. All purse monies must be returned to the association. The purse of this race is ordered redistributed as follows:
