### STEWARDS RULING

Ruling number: 15-0031  
LGC Sample #0059213

Track: Turfway Park

Date: March 8, 2015

Trainer: Carlos A. Lopez

Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, pre-race blood sample number 0059213 taken from **FOUR AND FIVE RED**, who finished seventh in the fourth race at Turfway Park on February 6, 2015 contained total carbon dioxide (TCO<sub>2</sub>) at a concentration of 42 mmol/L (second offense in 365 days). After a formal hearing before the Board of Stewards you are hereby suspended **ONE HUNDRED TWENTY (120) days**, April 13, 2015 through August 10, 2015 (inclusive) and fined **ONE THOUSAND FIVE HUNDRED (\$1500.00) DOLLARS**. **FOUR AND FIVE RED** is disqualified and all purse money forfeited. Pari-Mutuel wagering is not affected by this ruling. During his suspension Mr. Lopez is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Mr. Lopez is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
