TEST: 1<sup>st</sup> 5 & 9, 2<sup>nd</sup> 3 & 6 (C 2), 3<sup>rd</sup> 2 & 5, 4<sup>th</sup> 1 & 3, 5<sup>th</sup> 10 & 11, 6<sup>th</sup> 3 & 5, 7<sup>th</sup> 5 & 11, 8<sup>th</sup> 4 & 8.

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE A Stewards Inquiry into the top 4 finishers in the stretch was posted and, in addition, an objection was lodged by the rider of second place #6 "Tornado Boy" (Thiago Canuto) alleging interference by the rider of the unofficial winner, #3 "Draft Capital" Rafael M. Hernandez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #3 drifted out throughout the stretch and impeded the progress of #6. For the interference, #3 was disqualified and placed second, behind #6. It was also determined during the inquiry that the interference from #3 involving third place #8 "Here Comes Trey" (Samuel Bermudez) and fourth place #5 "Tallestofthetall" (Fernando De La Cruz) occurred close to the finish and did not affect the outcome of the race for those two horses. Therefore, no additional disqualification was ordered.

3<sup>rd</sup> RACE Voided claim - no race number on envelope

4<sup>th</sup> RACE Program correction: #6 "Fight Fiercely" was mistakenly listed to race with Lasix. The error was discovered and the horse was permitted to race without the medication. The change was posted and announced prior to the opening of wagering.

5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE #3 "Caramelito" (Santo Sanjur) was pulled up at near the 1/16 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was later reported that the horse had been transported to a Lexington clinic and, after evaluation, the horse was humanely euthanized due to poor prognosis.

8<sup>th</sup> RACE A Stewards Inquiry was posted and, in addition, an objection was lodged by the rider of second place #8 "Liam the Brave" (Santo Sanjur) alleging interference by the rider of the unofficial winner #4 "Kinison" (Jack Gilligan) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #4 drifted out in the stretch and caused #8 to steady and lose momentum. For the interference #4 was disqualified and placed second behind #8.
