1st RACE An objection was lodged by the rider of fourth place #2 "Grey Charmer" (Fernando De La Cruz) alleging interference by the rider of the unofficial winner #3 "Indefatigable" (Walter Rodriguez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight interference was initiated by #2 who lodged the objection. There was no change in the order of finish and the race was posted official.

The claim of #2 "Grey Charmer" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
