RACE An objection was lodged by the rider of second place #1 "Kick Rocks Kid" (David Haldar) alleging interference by the rider of the unofficial winner, #6 "Meatloaf's Chance" (Rafael M. Hernandez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the rider of #1 checked and angled out and around #6, while still having room to remain inside. There was no change in the order of finish and the race was posted official.

The claim of #2 "One Ace" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits

7th RACE A Stewards Inquiry was posted when the rider of #7 "Petit Verdot" (Rafael M. Hernandez) was unseated near the 3/8 pole while between horses. The loose horse required the assistance of the KHRC veterinarians and the horse ambulance. After a review of the race replay it was determined that no other horse had been involved in the incident and the race was posted official. It was later reported that the the horse had suffered a catastrophic injury to his left shoulder and he was humanely euthanized.
