3<sup>rd</sup> RACE A Stewards Inquiry was posted involving third place #2 "Shannonrun" (Abel Lezcano) in the stretch. In addition, the rider of fifth place #1 "Cactus Kevin" (Sonny Leon) lodged an objection alleging interference by the rider of fourth place #4 "Liams Lad" (Yarmarie Correa) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #2 angled out and made contact with #4 who in turn came out into the path of #1. Both #4 and #1 were forced to steady and lose momentum. For the interference, #2 was disqualified and placed fifth behind #4 and #1.


