After reviewing the race replay and interviewing the riders, the stewards determined that #2 angled out and made contact with #4 who in turn came out into the path of #1. Both #4 and #1 were forced to steady and lose momentum. For the interference, #2 was disqualified and placed fifth behind #4 and #1.
