RACE #6 "Under the Couvers" (Luan Machado) hit the front doors, popping them open prior the start, but was held in place by the assistance starter. The door were closed and the start was without incident.

An objection was lodged by the trainer (Kathy Jarvis) of third place #1 "Raf" (Joseph Ramos) alleging interference by the rider of second place #2 "Agnelli" (Alex Achard) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.

RACE CLEAR

#8 "Creative Courage" (Javier Padron-Barcenas) RACE was trailing the field and was nearing the 1/4 pole when it appeared that the rider was unable to control him and he ran through the outside fence, unseating the rider. The horse was quickly attended to by the KHRC veterinarians and the horse ambulance. It was later reported that the horse had appeared to suffer a sudden death.
