5th RACE A Stewards Inquiry was posted involving several horses in the stretch and, in addition, an objection was lodged by the rider of sixth place #9 "Archie the Giza" (Alex Achard) alleging interference by the rider of third place #1 "First Strike" (Gerardo Corrales) in the stretch. After reviewing the race replay and interviewing the riders of #1, #9, seventh place #7 "Evan Harlan" (Declan Cannon) and eighth place #2 "Emirates Road" (Luan Machado), the stewards determined that #1 angled out sharply and caused the riders of #8, #7 and #2 to check, steady, and lose momentum. For the interference #1 was disqualified from third and placed eighth, behind #2.
