A Stewards Inquiry was posted involving the unofficial winner #2 #First Hill" (John McKee) and seventh place #9 "Kaya's Halo" (Samuel Bermudez) in the stretch. In addition, the rider of fourth place #3 "R Queen Candy" (Walter Rodriguez) lodged an objection alleging interference by the rider of second place #7 "Phat Chance Fancy" (Erick Fuentes) in a separate incident, also in the stretch. After reviewing the race replay and interviewing the riders involved in both incidents, the stewards made the following determinations:

The objection lodged by the rider of #3 was disallowed due to insufficient evidence of interference to warrant the disqualification of #7.

In the separate incident, #2 ducked out sharply in the stretch, causing #9 to clip her heels, bobble, and lose all chance. For that interference #2 was disqualified from first and placed seventh, behind #9.

After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.
