4<sup>th</sup> RACE Voided claim - owner name misspelled

5<sup>th</sup> RACE A Stewards Inquiry was posted when #3 "Cash Alley" (Joseph D. Ramos) unseated his rider leaving the 3/8 pole. After reviewing the race replay and interviewing several riders that were in the vicinity of the incident, the stewards determined that the horse had propped and unseated Ramos and that no other rival was involved. There was no action taken and the race was posted official. The horse ran behind the field and was caught by the outrider. Ramos escaped injury. Cash Alley was placed on the Stewards List.
