TEST: 1<sup>st</sup> 3 & 7, 2<sup>nd</sup> 1 & 3, 3<sup>rd</sup> 1 & 2, 4<sup>th</sup> 1 & 10, 5<sup>th</sup> 3 & 6, 6<sup>th</sup> 1 & 4, 7<sup>th</sup> 3 & 8, 8<sup>th</sup> 4 & 9.

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE #6 "Samoa (Joseph Ramos) was a late scratch from the post parade on the advice of the KHRC veterinarian.

#7 "Live It Up" (Sonny Leon) stumbled badly at the start, unseating her rider. The horse ran along with the field and was captured by the outrider without incident. Both horse and rider escaped injury.

#1 "Seven Kingdoms" (Santiago Gonzalez), the winner, BLED and required the assistance of the KHRC veterinarians and the horse ambulance. A post-race blood sample was collected and the horse was excused from the test barn. The horse was placed on the See State Vet list.

5<sup>th</sup> RACE #2 "Peacebethejourney" (Rolando Aragon) broke down and fell near the 1/8 pole, unseating her rider. #7 "Edgee Angel" (Luan Machado) could not avoid the fallen horse and her rider was also unseated in the stretch. The KHRC veterinarians determined that the filly had suffered a catastrophic injury to her right foreleg and she was humanely euthanized. Rolando Aragon was transported to the hospital with a suspected wrist injury. Luan Machado escaped injury. "Edgee Angel" who collided with the fallen horse, also escaped injury.
