A Stewards Inquiry was posted involving several horses shortly after the start and, in addition, an objection was lodged by the rider of second place #5 "Virgin Colada" (Fernando De La Cruz) alleging interference by the unofficial winner #7 "Befriended" (Luan Machado) shortly after the start. After reviewing the race replay and interviewing the riders, the stewards determined that #9 ducked in and caused #5 to steady sharply and lose momentum. For the interference, #7 was disqualified and placed second, behind #5.
