5th RACE A Stewards Inquiry was posted involving the top 4 finishers in the stretch and, in addition, an objection was lodged by the rider of second place #4 "Like the King" (Rafael Bejarano) alleging interference by the rider of the unofficial winner #8 "Hush of a Storm" (Santiago Gonzalez) in the stretch. After reviewing the race replay and interviewing the 4 riders involved the stewards determined that while #8 drifted in slightly, there was still sufficient room for the two horses to his inside to the finish. #7 "Hard Rye Guy" (Chris Landeros) vacated his spot on the rail and changed course on his own before the drifting occurred. There was no change in the order of finish and the race was posted official.

6th RACE An objection was lodged by the rider of fifth place #13 "Nurturing" (Gerardo Corrales) alleging interference by the rider of third place #9 "Polka Polenta" (Alex Achard) leaving the 3/16 pole. After reviewing the race replay and interviewing the riders the stewards determined that the rider of #13 caused his own trouble by allowing his horse to drift in and make contact with #9, who maintained a straight course. There was no change in the order of finish and the race was posted official.
