An objection was lodged by the rider of fourth place #9 "Yeahiknow" (Santiago Gonzalez) alleging interference by the rider of third place #8 "Half Trick" (Edgar Morales) near the 1/4 pole. After reviewing the race replay and interviewing the riders the stewards determined that #8 stepped out into the path of #9, causing him to steady and lose momentum. For the interference \$8 was disqualified and placed fourth, behind #9.

The claim of #4 "Gold Hawk" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
