RACE A Stewards Inquiry was posted involving several horses in the stretch and, in addition, objections were lodged by the riders of both second place #4 "Swall" (Joseph Talamo) and fourth place #6 "Peacock Lass" (Alex Achard) alleging interference by the rider of the unofficial winner #1 "Laura's Charm" (Axel Concepcion) in the stretch. After interviewing all riders involved, the stewards determined that #1 bore out sharply in the stretch, making contact with #6 and also impeding #4 to her outside. For the interference #1 was disqualified from first and placed fourth, behind #6.
