**STEWARDS RULING**

**Ruling number: 20-0091**

**Owner: Merrill C. Roberts (D.O.B. 8/13/1941)**

Upon receipt of notification from Industrial Laboratories, the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at Texas A & M Veterinary Medical Diagnostic Laboratory, sample number E378490 taken from MR. MUTADDA, who finished fourth in the tenth race at Churchill Downs on October 29, 2020 contained phenylbutazone at a level of 0.929 ug/ml in blood (Class C drug). Merrill C. Roberts waived his right to a formal hearing before the Board of Stewards. MR. MUTADDA is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. All purse monies must be returned to the association. The purse of this race is ordered redistributed as follows:
