**STEWARDS RULING**

**Ruling number: 20-0092**

**Track: Turfway Park**

**Date: December 28, 2020**

**Owner/Trainer: Carol Cobb**

Pursuant to the August 31, 2020 and September 10, 2018 Opinions and Orders of the Franklin Circuit Court in *Carol Cobb vs. Kentucky Horse Racing Commission*, Civil Action No. 13-CI-702, affirming the Public Protection Cabinet's June 5, 2013 Final Order in Carol Cobb vs. KHRC (Administrative Action #KHRC-11-TB-004), Owner/Trainer Carol Cobb is hereby suspended ONE HUNDRED EIGHTY (180) days, January 1, 2021 through June 29, 2021 (inclusive). TRICKY TOKYO, who finished third in the first race at Turfway Park on January 14, 2011, is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. During her suspension, Carol Cobb is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Carol Cobb is denied pending transfer to persons acceptable to the stewards. The purse of this race is ordered redistributed as follows:
