STEWARDS RULING

Ruling number: 20-0017

Track: Turfway Park

Owner/Trainer: Edward H. Frederick and Owner: Stephen R. Baker

Pursuant to the November 26, 2019 Opinion and Order of the Franklin Circuit Court in *Edward H. Frederick vs. Kentucky Horse Racing Commission*, No. 16-CI-00625, affirming the June 2, 2016 Public Protection Cabinet Office of Administrative Hearings Final Order in *Edward H. Frederick vs. KHRC* (Administrative Action #KHRC-15-TB-003), Owner/Trainer Edward H. Frederick is hereby suspended ONE HUNDRED THIRTY FIVE (135) days, April 6, 2020 through August 18, 2020 (inclusive) and fined FIVE HUNDRED (\$500.00) DOLLARS. NIGHT LEAGUE, who finished third in the seventh race at Turfway Park on February 22, 2015 is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. During his suspension Mr. Frederick is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Mr. Frederick is denied pending transfer to persons acceptable to the stewards. The purse of this race is ordered redistributed as follows:
