On March 16, 2021, the Kentucky Horse Racing Commission ("KHRC") received a letter from Churchill Downs Racetrack, LLC d/b/a Derby City Gaming, LLC ("DCG"), requesting to offer new Ainsworth Game Technology ("Ainsworth"), International Game Technology ("IGT"), and Konami Gaming, Inc. ("Konami") entertaining game themes, pari-mutuel pools, and system components.

Submitted with this letter were certification reports published by Gaming Laboratories International ("GLI") and BMM International ("BMM"), two (2) independent, third-party testing laboratories under contract with the KHRC.

GLI has certified nine (9) new Ainsworth entertaining game themes and pari-mutuel pools as compliant with all applicable Kentucky statutes and regulations. KHRC staff has reviewed these certification reports and believes that all requested Ainsworth components offer pari-mutuel wagering on historical horse racing under Kentucky statutes and regulations.

BMM has certified nine (9) new IGT entertaining game themes and pari-mutuel pools as compliant with all applicable Kentucky statutes and regulations. KHRC staff has reviewed these certification reports and believes that all requested IGT components offer pari-mutuel wagering on historical horse racing under Kentucky statutes and regulations.

In its letter, DCG also requested approval for five (5) new Konami entertaining game themes and two (2) new pari-mutuel pools. This is the first request to offer Konami entertaining game themes, pari-mutuel pools, and system components that the KHRC has



received from any licensed association operating under its jurisdiction. Konami operates through totalizator services provided by Ainsworth Game Technology. As such, the parimutuel wagering and accounting is similar to that of previously approved parimutuel pools operated by Scientific Games, Inc., IGT, and Ainsworth. GLI has certified all Konami entertaining game themes and parimutuel pools as well as other pertinent software required to operate these components.

If approved by the KHRC, DCG staff will transition the affected HHR terminals to the new entertaining game themes, pari-mutuel pools, and system components in a secure manner, with guidance from KHRC staff. Please see the enclosed component list for a description of all changes proposed by DCG. A copy of the certification reports will be made available to the Commissioners upon request.

KHRC staff recommends approval of this DCG request to offer new Ainsworth, IGT, and Konami entertaining game themes, pari-mutuel pools, and system components.

Re:	Proposed Classification Process for Historical Horse Racing Administrative Requests

Please allow this memorandum to serve as a summary of the proposed process for classifying administrative requests relating to historical horse racing ("HHR").

It should be noted that any racing association's initial request to offer an exotic wager on HHR is subject to the review and approval by a quorum of the KHRC's appointed membership. However, the KHRC also frequently receives various requests to modify certain aspects of a racing association's existing, previously approved HHR operations.

Although some of the submitted requests are substantive—and therefore require the consideration of a quorum of the KHRC's appointed membership, as all initial requests undergo—many other requests could be more appropriately classified as administrative. Nevertheless, 810 KAR 1:120, 811 KAR 1:250, and 811 KAR 2:160 are all clear in their requirement that "An association shall not implement any change or modification to the practices, procedures, or representations upon which the approval of the exotic wager was based without the prior written approval of the commission."

Because the KHRC only meets in its entirety on a bi-monthly basis, requiring an approval of all administrative requests by a quorum of the KHRC's appointed membership would create a cumbersome process that would impede licensed racing associations from managing their day-to-day business operations in an effective and efficient manner. As such, the KHRC staff recommends that the KHRC expressly authorize the KHRC's Executive Director to approve or deny administrative requests related to HHR. This delegation is appropriate pursuant to KRS 230.230, which vests the Executive Director with responsibility for "the day-to-day operations of the racing commission."

In granting this authority, some of the Executive Director's decisions on any such administrative requests would remain subject to subsequent review and ratification by a quorum of the KHRC's appointed membership. Other decisions would be appropriate for approval without ratification—particularly those that implement items previously approved by a quorum of the KHRC's appointed membership.

Due to the unique nature of many HHR requests, their classification will be handled on a case-by-case basis. With that being said, each of the following lists—, which are not all-inclusive and are instead intended to be illustrative—provides the proposed classification process for HHR administrative requests.

Approval of HHR Administrative Requests by Executive Director:

- Requests to alter floor layout (switching, moving or replacing terminals, etc.);
- Requests to update software accompanied by relative independent, third party testing laboratory reports (minor changes, integrity fixes);
- Requests to offer entertaining game themes operating through pari-mutuel pools previously approved/ratified by a quorum of the KHRC's appointed membership;
- Requests to alter operating hours;
- Requests to deploy previously approved terminals, pari-mutuel pools, entertaining game themes, system components accompanied by relative independent, third party testing laboratory reports, etc.; and
- Requests to host demonstration units at KHRC licensed facilities.

Approval of HHR Requests by Executive Director, Subject to Ratification by the <u>KHRC</u>

• Requests to offer new HHR terminals, pari-mutuel pools, entertaining game themes operating through new pari-mutuel pools, system components accompanied by relative independent, third party testing laboratory reports.

Approval of HHR Requests by a quorum of the KHRC's appointed membership:



- Requests to increase total allotment of HHR terminals for KHRC licensed facilities; and
- Requests for expansion of HHR-designated floor space.

In sum, the KHRC staff believes that the above-referenced grant of authority to the Executive Director would be appropriate under the outlined circumstances, and recommends approval of this memorandum.
