RE: REQUEST FOR APPROVAL OF SPORTS WAGERING CATALOG RECOMMENDATIONS

In accordance with 809 KAR 10:002, a licensee is prohibited from offering sports wagering on any event that has not been approved by Kentucky Horse Racing and Gaming (KHRG). This memorandum presents proposed updates to the KHRG's Sports Wagering Catalog, ensuring compliance with KHRG regulations. The proposed changes include staff recommendations regarding requests for new sporting events or clarifications from licensed service providers.

KHRG staff has thoroughly reviewed these requests to ensure they adhere to the criteria for allowable wagers as established in 809 KAR 10:002, Section 2. This review focused on the overall integrity of the sporting events associated with each request and their suitability for offering in Kentucky. KHRG staff evaluated each event to ensure it meets the regulatory standards for transparency, integrity, and relevance to the field of play.

#### **New Requests and Clarification**

The following requests, submitted by service providers, have been reviewed and evaluated by KHRG staff. Below is additional information regarding each request, along with corresponding recommendations:

RE: REQUEST FOR APPROVAL OF INDEPENDENT TEST LABORATORIES FOR 2026

Pursuant to KRS 230.260, Kentucky Horse Racing & Gaming (KHRG) is responsible for establishing and enforcing regulatory standards for sports wagering, pari-mutuel wagering, and charitable gaming in the Commonwealth of Kentucky. This authority includes the approval of independent test laboratories ("ITLs") that assess the compliance, integrity, and technical performance of wagering systems and equipment prior to deployment.

Through the KHRG Board of Directors, KHRG has implemented a formal application and review process for the approval of laboratories that provide such independent testing services. These laboratories must demonstrate the capacity to conduct unbiased testing of systems, platforms, and equipment used in wagering operations under Kentucky's regulatory framework.

As part of the review process, staff evaluated each applicant's general suitability, business structure, operational capacity, and experience working with regulatory agencies in other jurisdictions. The review also included a high-level assessment of each laboratory's independence, testing capabilities, technical personnel, and history of regulatory compliance. Both applicants provided documentation supporting their qualifications and demonstrated their ability to conduct testing in a manner consistent with KHRG's standards and expectations.

#### **SUMMARY OF ITL APPROVAL APPLICATIONS**

1. BMM North America, Inc. ("BMM")

BMM is accredited under ISO/IEC 17025. BMM has demonstrated technical competence in evaluating wagering platforms and wagering devices consistent with

Kentucky's technical standards.

**Recommendation:** Approve BMM as an Independent Test Laboratory.

2. Gaming Laboratories International, LLC ("GLI")

GLI is also ISO/IEC 17025 accredited. The laboratory has a robust history of testing and certifying wagering systems, software platforms, and components for regulatory compliance. GLI has demonstrated the qualifications, independence, and capacity to serve as a testing partner under Kentucky's regulatory framework.

**Recommendation:** Approve GLI as an Independent Test Laboratory.

**Staff Recommendation** 

Based on the evaluation of each applicant's qualifications and submitted documentation, KHRG staff recommends approval of BMM and GLI as Independent Test Laboratories authorized to conduct testing and certification of wagering systems for compliance with Kentucky's statutes, regulations, and technical standards.

KHRG reserves the right to request additional information and conduct periodic reviews or audits of any approved ITL. Approval may be revoked or suspended in the event of noncompliance, conflicts of interest, or other material concerns.

RENEWALS FOR 2026

Pursuant to KRS 230.260, the Kentucky Horse Racing and Gaming (KHRG) is tasked with establishing regulatory standards for sports wagering within the Commonwealth of Kentucky. Under KRS 230.811 and KRS 230.814, licensed service providers are authorized to conduct sports wagering activities. Service provider licenses require an initial application fee of \$50,000 and an annual renewal fee of \$10,000.

As a part of the application renewal review process, KHRG staff reviewed items including organizational structure, key personnel, technical requirements and certification, the contract to provide services to a sports wagering operator and contracts with other entities requiring occupational licenses. Throughout the duration of the license, applicants must furnish details concerning significant changes to ownership structure, server equipment and software, arrangements with third-party service providers, house rules, internal controls, and potential impacts on the Commonwealth of Kentucky. KHRG staff may request clarification for any documentation submitted prior to or throughout the duration of the license.

The following memorandum provides a summary of each service provider and the staff recommendation regarding their 2026 license renewal. Further details are available in the application files maintained at the KHRG office.

#### 1. American Wagering, Inc. ("Caesars Sportsbook")

Conducts retail and mobile wagering with Lexington Trots Breeders Association, LLC ("Red Mile").

**Recommendation:** Approval of the 2026 license renewal

#### 2. Betfair Interactive US, LLC ("FanDuel Sportsbook")

Conducts mobile wagering with Turfway Park, LLC ("Turfway Park").

**Recommendation:** Approval of the 2026 license renewal

#### 3. BetMGM, LLC ("BetMGM")

Conducts retail and mobile wagering with Revolutionary Racing KY, LLC ("Sandy's Racing & Gaming").

**Recommendation:** Approval of the 2026 license renewal

#### 4. Circa Sports KY, LLC ("Circa Sports")

Conducts retail and mobile wagering with Kentucky Downs LLC ("The Mint Gaming Hall at Kentucky Downs").

**Recommendation:** Approval of the 2026 license renewal

#### 5. Crown KY, LLC ("DraftKings Sportsbook")

Conducts retail and mobile wagering with ECL Corbin, LLC ("The Mint Gaming Hall Cumberland") and ECL Entertainment LLC ("The Mint Gaming Hall at Bowling Green").

**Recommendation:** Approval of the 2026 license renewal

#### 6. FBG Global Holdco, LLC ("Fanatics Sportsbook")

Conducts mobile wagering with WKY Development, LLC ("Oak Grove Racing, Gaming & Hotel").

**Recommendation:** Approval of the 2026 license renewal

#### 7. Hillside (Kentucky), LLC ("Bet365")

Conducts mobile wagering with Revolutionary Racing KY, LLC ("Sandy's Racing & Gaming").

**Recommendation:** Approval of the 2026 license renewal

#### 8. Penn Sports Interactive, LLC (formerly dba "ESPN BET")

Conducts mobile wagering with Ellis Entertainment, LLC ("Ellis Park").

**Update:** Penn Sports Interactive, LLC has ended their relationship with ESPN and is no longer operating under the "ESPN BET" brand. The company started operating as "theScore Bet" on December 1, 2025. There has been no change in ownership, corporate structure, or operational control of Penn Sports Interactive, LLC. No service

interruption has occurred or is anticipated as a result of the rebranding.

Recommendation: Approval of the 2026 license renewal

9. Sports Information Services, Ltd. ("Kambi")

Conducts retail wagering with Churchill Downs Racetrack, LLC ("Churchill Downs Racetrack"), Ellis Entertainment, LLC ("Ellis Park"), Turfway Park, LLC ("Turfway Park"), and WKY Development, LLC ("Oak Grove Racing, Gaming & Hotel").

**Recommendation:** Approval of the 2026 license renewal

#### Staff Recommendation

The KHRG staff has reviewed the submissions and documentation provided by each service provider applicant for the 2026 licensing period. All entities have complied with regulatory requirements and submitted the required renewal fees. The staff recommends the approval of the 2026 sports wagering service provider licenses for the aforementioned applicants.

RE: RENEWAL AND PROPOSED CONDITIONS FOR THE 2026 SPORTS WAGERING SERVICE

PROVIDER LICENSE OF OUT THE GATE, LLC D/B/A PRIME SPORTS

KRS 230.290 provides that all licenses issued under KRS Chapter 230 "shall be subject to all administrative regulations and conditions as may from time to time be prescribed by the corporation." Pursuant to this statutory authority, the Kentucky Horse Racing & Gaming Corporation (KHRG) may impose any conditions necessary to ensure regulatory compliance, financial soundness, operational integrity, and protection of the wagering public. Out the Gate, Inc. d/b/a Prime Sports has submitted a timely renewal application for the 2026 licensing period, provided all requested supplemental documentation, and remitted the required renewal fee, and its application has been reviewed in accordance with applicable statutory and regulatory requirements.

In light of the recent filing of a Chapter 11 bankruptcy petition by Out the Gate, Inc. d/b/a Prime Sports (Prime Sports) on November 12, 2025, and the uncertainty that accompanies the early stages of that proceeding, as well as indications of a potential substantial change in ownership, KHRG staff recommends that the renewal of Prime Sports' 2026 service provider license be issued with conditions, including limiting the acceptance of wagers based on settlement date. Specifically, the proposed condition would prohibit Prime Sports from accepting wagers that are reasonably expected to settle after the court approved sale closing date. Prime Sports would be permitted to continue accepting wagers that are expected to settle on or before the applicable date, while continuing to settle all outstanding wagers and honor all player withdrawal requests.

This limitation is intended to protect Kentucky consumers by preventing the accumulation of wagering liabilities that extend beyond the applicable court-approved sale closing date, while still allowing for the orderly continuation of operations and fulfillment of existing customer

obligations. Tying the settlement limitation to that defined closing date provides a clear and objective safeguard for player funds during this transitional period, while allowing Prime Sports, the bankruptcy court, and any prospective purchasers or interested parties time to evaluate and complete longer-term business arrangements. The conditions proposed in the attached document address the limitation on wager acceptance based on settlement date, ongoing financial reporting, weekly reserve verification to protect outstanding Kentucky wagering liabilities, reporting obligations related to material corporate developments, ownership and control notifications, the maintenance of an agreement with a licensed racing association, and other measures necessary to preserve the integrity of sports wagering in Kentucky during this period of transition.

#### **Staff Recommendation**

KHRG staff has reviewed the timely renewal application, supporting documentation, and confirmed all required fees have been submitted by Out the Gate, Inc. d/b/a Prime Sports for the 2026 sports wagering service provider license. Based on this review, staff recommends approval of the renewal of Prime Sports' 2026 sports wagering service provider license, subject to the conditions attached.

### Kentucky Horse Racing & Gaming Conditions of Licensure Pursuant to KRS 230.260 and 230.290

Pursuant to KRS 230.260 and 230.290, the Kentucky Horse Racing and Gaming Corporation ("KHRG") is authorized to prescribe necessary and reasonable conditions under which sports wagering is conducted in the Commonwealth of Kentucky. Therefore, as a condition of service provider licensure by KHRG to conduct sports wagering, Out the Gate, Inc. d/b/a Prime Sports ("Prime Sports") shall certify that it shall comply with the following requirements:

#### 1. Limitation on Acceptance of Wagers Based on Settlement Date

Upon approval of these conditions, Prime Sports shall not accept any wager from a Kentucky customer that is reasonably expected to settle after the later of February 4, 2026, the bankruptcy court approved sale closing date, or the actual closing date of any court-approved sale. Prime Sports may continue to accept wagers that are expected to settle on or before that applicable date, provided such wagers are otherwise lawful and settled in the ordinary course of business.

Prime Sports shall continue to settle all outstanding wagers placed prior to the effective date of this condition and shall continue to process and honor all customer withdrawal requests fully and promptly. Prime Sports shall not offer, market, or accept wagers with delayed or contingent settlement dates extending beyond the applicable closing date, including but not limited to futures, seasonlong wagers, or similar wager types, unless expressly authorized in writing by KHRG.

Prime Sports shall not structure, modify, or reclassify wagers for the purpose of circumventing the settlement date limitation set forth in this condition.

#### 2. Weekly Reserve Attestation During Conditional Period

Prime Sports shall maintain sufficient funds to cover all Kentucky wagering liabilities outstanding from wagers placed. The reserve must also cover: (a) all cashable player account balances; (b) pending withdrawals; (c) unsettled wagers; and (d) unpaid winning wagers.

The reserve may consist of cash, cash equivalents, payment processor receivables, payment processor reserves, an irrevocable letter of credit, a bond, or any combination thereof, and shall be no less than the greater of twenty-five thousand dollars (\$25,000) or the total Kentucky liabilities listed above.

Prime Sports shall submit to KHRG each Monday by 5:00 p.m. Eastern Time:

- a) A reserve calculation;
- b) Documentation verifying the reserve is held in a segregated, non-operational account; and

c) An attestation confirming the reserve is fully funded, unencumbered, and immediately available.

If a verification date falls on a banking holiday, completion on the next business day is acceptable provided the reserve remains fully funded. KHRG may audit the reserve at any time and may order immediate corrective action.

#### 3. Protection of Kentucky Customers

Prime Sports shall ensure that Kentucky players may withdraw their funds at any time during the conditional period. Kentucky player funds shall not be transferred, pledged, commingled, or used for any purpose other than satisfying player withdrawals and outstanding wagering obligations.

Prime Sports shall provide KHRG with an accounting of all Kentucky player accounts within ten (10) business days after these conditions are executed and shall update KHRG upon request.

#### 4. Oversight During Bankruptcy Proceeding and Potential Sale or Corporate Transition

Prime Sports shall provide KHRG with copies of any filings, pleadings, motions, orders, or notices submitted to or received from any court, regulatory agency, or governmental body in connection with the bankruptcy proceeding, any proposed sale, or any other material change in the company's business operations. These documents shall be provided to KHRG within twenty-four (24) hours of filing or receipt. Prime Sports shall also immediately notify KHRG of any proposed asset sale, restructuring or reorganization plan, appointment of a trustee, examiner, or other third party to oversee operations, approval or modification of debtor-in-possession financing, or any other development that may affect the company's financial stability, governance, or suitability to hold a sports wagering service provider license in the Commonwealth.

This conditional license does not grant or imply approval of any sale, transfer, or purchaser. Any proposed sale, assignment, or transfer of any interest in the licensed entity or the service provider license shall be subject to a separate and independent suitability review and explicit written approval by the Board pursuant to 809 KAR 1:002 Section 7(3). No sale or transfer shall take effect for Kentucky licensure purposes without such approval.

#### 5. Agreement with a Licensed Racing Association

Prime Sports' continued licensure is contingent upon maintaining a valid and enforceable agreement with a licensed racing association pursuant to KRS 230.811. Prime Sports shall notify KHRG within twenty-four (24) hours of any notice of termination, expiration, non-renewal, challenge to validity, or any event

affecting enforceability of that agreement.

If the agreement becomes invalid or unenforceable, the conditional license shall immediately lapse.

#### 6. Conditions for Resumption of Full Operations

Prime Sports may resume accepting wagers without restriction as to settlement date, and may otherwise operate without the limitations imposed by these conditions, only after:

- a) The conclusion of any proposed sale, restructuring, or other material change in the company's business operations;
- b) KHRG determines, through a separate suitability review pursuant to 809 KAR 1:002 Section 7(3), that the purchaser is fit for licensure;
- c) Updated financial assurances, internal controls, and reserve documentation are submitted and approved; and
- d) KHRG issues written authorization removing the settlement date limitation.

Until these criteria are satisfied, the conditional license authorizes Prime Sports to conduct sports wagering only in compliance with the settlement date limitation and other conditions set forth herein, unless otherwise directed by KHRG in writing.

#### 7. Non-Compliance

Failure to comply with any provision of these conditions may result in immediate suspension or revocation of licensure, or any other action permitted under KRS Chapter 230 and Titles 809 and 810 of the Kentucky Administrative Regulations.

All notices required to be given to KHRG under this condition of licensure, unless otherwise stated, shall be provided to KHRG's Director of Sports Wagering via hand delivery or electronic mail. In the event Prime Sports does not comply with the requirements, KHRG has the authority to assess fines and/or penalties, including, but not limited to, licensure revocation. Additional conditions may be added to Prime Sport's license at any time at the discretion of KHRG.

RE: RATIFICATION OF PURCHASE REQUEST FOR LITIGATION SERVICES

On November 25, 2025, KHRG was served with a lawsuit regarding an order issued by KHRG. In an unrelated matter, litigation has been threatened by another licensee. Although an RFP for litigation services had been released and responses received, representation for litigation services was needed immediately.

Due to timing of litigation and threatened litigation, a Finance Committee meeting was not able to be scheduled before the need to have a vendor providing litigation services and negotiating a contract for those services. KHRG followed the Emergency Procurement procedures as outlined in the Procurement Policies. These procedures require the following:

- A request, in writing if possible, for a written determination shall be made to the President or her designee
- If she finds the condition exists for KHRG to purchase through an emergency procurement, KHRG may proceed with the emergency procurement
- If possible, the determination will be made in writing
- President or her designee shall make its reasonable best effort to obtain approval from the Finance Committee prior to making such a procurement, and if unable to do so, shall inform the Board of any action taken and the justification for such procurement and provide documentation regarding all efforts to obtain approval from the Finance Committee
- The determination will be submitted for ratification by the Board at its next meeting

The attached Purchase Request Form was shared individually with four of the five Finance Committee members by the CFO on the afternoon of November 25, 2025, after the KHRG board meeting. The CFO individually spoke with the members and addressed any questions raised. Additionally, the CEO spoke with the KHRG Board Chairman who did not have any concerns with the procurement. KHRG staff proceeded with retaining services from Frost Brown Todd, LLC, on November 26, 2025, with the contract not to exceed \$100,000.

KHRG staff recommends ratification by the Board of the Purchase Request for Litigation Services.
