The Gaming Compliance Auditor provides compliance and auditing services to Kentucky Horse Racing & Gaming's (KHRG) Gaming Division. The Gaming Compliance Auditor reports to the Senior Vice President of Gaming, but works directly with the directors of pari-mutuel wagering, sports wagering, and charitable gaming on a day-to-day basis. They are responsible for ensuring proper reporting and regulatory compliance by KHRG licensees involved in wagering activities, with a focus on organizations conducting charitable gaming.
