**STEWARDS RULING**

**Ruling number: 21-0016**

Upon receipt of notification from Industrial Laboratories, the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at UIC Analytical Forensic Testing Laboratory, sample number E377808 taken from GAMINE, who finished third in the twelfth race at Churchill Downs on September 4, 2020 contained betamethasone in blood (Class C drug). Michael Lund Petersen waived his right to a formal hearing before the Board of Stewards. GAMINE is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. All purse monies must be returned to the association. The purse of this race is ordered redistributed as follows:
