7th RACE An objection was lodged by the rider of fifth place #10 "Hard Rye Guy" (Fernando De La Cruz) alleging interference by both the rider of second place #7 "Master of the Ring" (Gerardo Corrales) and the unofficial winner #4 "Warbird" (Walter A. Rodriguez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was no interference caused by #4 and that objection was disallowed. It was also determined that #7 drifted out and caused #10 to clip heels, steady, and lose momentum. For the interference, #7 was disqualified from second and placed fifth, behind #10.
