1st RACE CLEAR

2nd RACE #1 "We'll Do It Live" (Dylan Machado) was a late scratch from the post parade on the advice of the KHRG veterinarian. Seven claims that had been submitted for the horse were voided.

5th RACE Jackpot 8 wagering was not offered when the field was reduced to seven prior to the opening of wagering.

6th RACE CLEAR

7th RACE A Stewards Inquiry was posted involving several horses in the stretch and, in addition, an objection was lodged by the rider of sixth place #4 "Modern Escape" (Brooke Bays) alleging interference by the rider of third place #9 "Black Rose" (Luan Machado) and also by the rider of seventh place #7 "My Secret Dreams" (Edgar Morales) alleging interference by the rider of the unofficial winner #5 "Knockonwood" (Rafael M. Hernandez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #5 angled in and caused #7 to clip heels and nearly unseat the rider, who lost his irons, and caused a chain reaction that also affected #9 and #4 on the inside, causing them both to steady. Because the interference was determined to have been caused by #5, the objection by the rider of #4 was disallowed. For the incident, #5 was disqualified from first and placed seventh, behind #7. Official order of finish: 1-9-2-3

8th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.
