1st RACE CLEAR

2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#1 "Big Boy Thunder" (Summer Pauly) finished second and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

3rd RACE #6 "Lady Lancer" (Carlos Barbosa) was a late scratch from the post parade on the advice of the KHRG veterinarian.

4th RACE The claim of #2 "Collecting" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE CLEAR

6th RACE CLEAR

7th RACE Program correction - #4 "Smooth Whiskey" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

8th RACE CLEAR

9th RACE #4 "Golden Graham" (Luis Contreras) unseated his rider in the post parade and ran loose, evading the outriders until finally being apprehended, and was scratched by the stewards. This being the second time the gelding had been scratched due to his unruliness in the post parade, he was placed on the Stewards List.

10th RACE Voided claim - used stable name only

#4 "Sassagoula River" (Gabriel Saez) was unruly in the paddock, broke post parade and was taken behind the starting gate while the field warmed up. The horse was ultimately injured while behind the gate and was a late scratch on the advice of the KHRG veterinarian.
