1st RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

2nd RACE CLEAR

3rd RACE #6 "Galantini" (Rafael M. Hernandez) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

5th RACE Voided claim - envelope improperly completed

8th RACE Voided 2 claims - submitted for scratched horse.

A Stewards Inquiry was posted involving several horses near the 3/16 pole and, in addition, an objection was lodged by the rider of seventh place #2 "Legend of Bobby C" (John McKee) alleging interference by the rider of sixth place #1 "English Bobby" (Adam Beschizza) near the 3/16 pole. After reviewing the race replay and interviewing the riders of fifth place #5 "Saki Bomb" (Xarel Forde), #2 and #1, the stewards determined that #5 angled out sharply and caused #1 to steady and make contact with #2 to his outside, who also was forced to steady. Because the incident was caused by #5, the horse was disqualified and placed seventh, behind #2. Also, because the first four finishers were not involved, the race was posted official while the incident was reviewed and decided. There was no change to the original order of finish: 4-8-6-7
