The claim of #4 "Captain Gabe" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE CLEAR

6th RACE #1 "J David" (Luis Contreras) flipped in the gate, unseated his rider, and was a late scratch on the advice of the KHRG veterinarian. Both horse and rider escaped serious injury.

7th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

A Stewards Inquiry was posted involving an incident near the 3/16 pole and, in addition, the rider of fifth place (last) #1 "Fantastical" (Edgar Morales) lodged an objection alleging interference by the rider of fourth place #2 "Girl of My Dreams" (Constantino Roman) near the 3/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that the rider of #1 lacked room while between horses, causing him to clip heels and nearly be unseated, losing his irons. There was no change in the order of finish and the race was posted official.

8th RACE CLEAR

9th RACE #2 "Pretti Boujee" (Constantino Roman) was injured in the paddock and was a late scratch on the advice of the KHRG veterinarian.

#4 "Tricky Furey" (Martin Garcia) was a late scratch from the post parade on the advice of the KHRG veterinarian.
