1<sup>st</sup> RACE An objection was lodged by the rider of fourth place #3 "Factum's Star" (Thiago Canuto) alleging interference by the rider of second place #7 "On Palm Sunday" (Yarmarie Correa) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.

4<sup>th</sup> RACE #7 "Communication Memo" (Joseph Ramos) was a late scratch from the post parade on the advice of the KHRGC veterinarian.

The claim of #2 "Zombie" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
