1st RACE CLEAR

2nd RACE #3 "Buy the Rights" (Danny Sheehy) was a late scratch from the post parade on the advice of the KHRG veterinarian.

3rd RACE Both #3 "Triple Max" (Gerardo Corrales) and #11 "Mister Landry" (Rafael M. Hernandez) were scratched from the post parade on the advice of the KHRG veterinarian.

4th RACE CLEAR

5th RACE #3 "Equity" (Luan Machado) was a late scratch from the post parade on the advice of the KHRG veterinarian.

#1 "Coach Bargatze" (Joel Rosario) was pulled up near the 5/8 pole and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

6th RACE CLEAR

7th RACE CLEAR

8th RACE An objection was lodged by the rider of second place #4 "Steel Imperium" (Vincent Cheminaud) alleging interference by the rider of the unofficial winner #8 "Bull by the Horns" (John Velazquez) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

#8 "Hometown Bound" (Victor R. Carrasco) was eased and left the track on his own power. The KHRG veterinarians later reported that the horse had returned lame and was placed on the See State Vet list.

9th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

10th RACE #8 "Wadsworth" (Irad Ortiz, Jr.) fifth and required the assistance of the KHRG veterinarians. The horse, who was treated for a post-race heatstroke, was placed on the See Vet list.

11th RACE CLEAR

12th RACE #8 "Chaos Agent" (Joel Rosario) was pulled up at the 3/16 pole and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had suffered physical distress and he was placed on the See State Vet list.

13th RACE #6 "New Rose" (Victor R. Carrasco) was a late scratch from the post parade on the advice of the KHRG veterinarian.
