TEST: 1st 3 & 7, 2nd 5 & 6 (C 3-voided), 3rd 2 & 6 (C 1), 4th 3-clm voided & 10 (C 5 & 8), 5th 1-clm voided & 10 (C 11), 6th 1 & 5, 7th 1 & 2, 8th 1 & 11, 9th 8 & 10.

1st RACE CLEAR

2nd RACE A Stewards Inquiry was posted into the stretch run and, in addition, an objection was lodged by the rider of second place #5 "Not So Easy" (Joseph Ramos) alleging interference by the rider of the unofficial winner, #6 "Vettori Kin (BRZ)" (Gerardo Corrales) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #6 drifted out through the stretch forcing #5 to steady and lose momentum. For the interference #6 was disqualified and placed second behind #5.
Official order of finish: 5-6-8-1

#3 "Storm Risk" finished ninth (last), BLED, and required the assistance of the KHRC veterinarians and the horse ambulance. A claim submitted for the horse was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list.

3rd RACE There was a 32 minute tote delay after the running of this race. Due to a tote issue, the video department was unable to display the order of finish until the problem was corrected. During the delay the horses remained in the paddock without incident.

4th RACE The claim of #3 "Can't Hide From Me" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE Voided claim - submitted for scratched horse

The claim of #1 "Biggie" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6th RACE CLEAR

7th RACE An objection was lodged by the rider of fourth place #9 "Hot Heels" (Luan Machado) alleging interference by the rider of the unofficial winner #2 "Dialed Inna" (Walter Rodriguez) near the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.
