Both horse and rider escaped injury. The late scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

9th RACE #9 "Vezpa (BRZ)" (Joseph Ramos) unseated her rider approaching the 1/4 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the mare had suffered a catastrophic injury to her right foreleg and she was humanely euthanized. The rider was not injured.
