1st RACE CLEAR

2nd RACE A Stewards Inquiry was posted involving the start of #7 "Chic N Da Wadda" (Agustin Gomez) who unseated her rider at the start. After reviewing the race replay and interviewing the starter and rider, the stewards determined that the horse had not been restrained or precluded from obtaining a fair start, but that the horse flipped as the gate opened, throwing her rider out over the back door. The horse was considered a starter and the race was posted official. Both horse and rider escaped injury.

#4 "Urban Cowgirl" (Joseph D. Ramos) finished eighth and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the mare had returned lame and she was placed on the See State Vet list.

The claim of #10 "Sandrinha Love" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

#10 "Centeya" (Fernando De La Cruz) was a late scratch from the post parade on the advice of the KHRG veterinarian. A claim that had been submitted for the horse was voided.

#6 "Last Chance Dance" (Kevin J. Jimenez) was pulled up abruptly near the 3/16 pole and required the assistance of the KHRG veterinarians and the horse ambulance. It was determined that the mare had suffered a catastrophic injury to her right foreleg and she was humanely euthanized.

6th RACE #1 "Fascinator" (Oscar Villarreal) was a late scratch from the post parade on the advice of the KHRG veterinarian.
