5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE Both #4 "Golden Reign" (Luan Machado) and #8 "Maya Prince" (Gabriel Saez) were late scratches from the post parade on the advice of the KHRG veterinarian. A claim submitted for #8 was voided.

The claim of #11 "Penrod" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

7<sup>th</sup> RACE #11 "Spotty Showers" (Alberto Burgos) was a late scratch from the post parade on the advice of the KHRG veterinarian.

8<sup>th</sup> RACE CLEAR

9<sup>th</sup> RACE Following a close photo finish and before the unofficial order of finish was posted, the rider of #11 "Prophetic Debby (IRE)" (Joseph D. Ramos) lodged an objection alleging interference by the rider of #1 "Lady Faye" (Walter A. Rodriguez) in the stretch. Soon after the objection was lodged, the order of finish was posted revealing that #11 had finished first, making the review of the objection unnecessary. There was no change in the order of finish (11-1-8-10) and the race was posted official.

10<sup>th</sup> RACE #12 "High End" (Dylan Machado) was injured in the paddock and was a late scratch on the advice of the KHRG veterinarian.
