3rd RACE An objection was lodged by the rider of seventh place #3 "Willyoubemine" (Rogelio Miranda) alleging interference by both the riders of second place #6 "Native Lion" (Samuel Bermudez) and the unofficial winner #10 "Woke Up to Aces" (Drayden Van Dyke) in the first turn. In addition, the trainer (Tianna Richardville) of #6 lodged an objection against #10 in the first turn. After reviewing the race replay and interviewing the riders, the stewards determined that the rider of #6 appeared to anticipate interference from the outside, stood up and checked sharply, but always had room, while the rider of #3 lacked room and checked. There was no change in the order of finish and the race was posted official.

5th RACE #5 "Run Run Rapidash" (Gabriel Lagunes) was a late scratch from the post parade on the advice of the KHRC veterinarian.


8th RACE #3 "Randella" (Malcolm Franklin) was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.





12th RACE There was a 30 minute delay in posting the payoffs after race 11 was made official. During the delay the horses for race 12 remained in the paddock without incident. An full report from United Tote will be furnished to the KHRC.
