7<sup>th</sup> RACE An objection was lodged by the rider of third place #10 "Protomagic" (Axel Concepcion) alleging interference by the rider of second place #9 Ruthless Rua" (Walter A. Rodriguez) leaving the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #10 angled out sharply into the path of #9, causing him to steady and lose momentum. For the interference #9 was disqualified from second and placed third behind #10. Official order of finish: 13-10-9-2
