After reviewing the race replay, the stewards determined that the horse caused his own trouble when broke awkwardly, hitting the side of the gate and losing the rider. There was no action taken and the race was posted official.

8th RACE An objection was lodged by the rider of third place #5 "My Secret Dreams" (Xarel Forde) alleging interference by the rider of the unofficial winner #2 "Cool American" (Danny Sheehy). After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.
