4th RACE The claim of #8 "Landing Craft" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE #9 "God of Wine" (Alex Achard) was a late scratch from the post parade on the advice of the KHRG veterinarian.

7th RACE An objection was lodged by the rider of third place #8 "Blue Flame Six" (Alex Achard) alleging interference by the rider of the unofficial winner #5 "Hen Party" (Walter A. Rodriguez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.

8th RACE Program correction - #8 "Lazlo" was mistakenly listed in the program to race without Lasix. The error was caught in a timely manner and the horse was permitted to race with the medication. The correction was posted and announced prior to the opening of wagering.
