TEST: 1st 3-clm voided & 5 (C 7), 2nd 2 & 8 (C 5 & 7), 3rd 4 & 7 (C 9), 4th 4 & 9, 5th 8 & 11-clm voided (C 6), 6th 1 & 11 (C 7 & 8), 7th 7 & 11, 8th 5 & 10.

1st RACE The claim of #3 "Video Princess" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE A Stewards Inquiry was posted when the rider of #5 "Bel Aria" (Erick Fuentes) was unseated while in tight quarters near the 5/16 pole. In addition, an objection was lodged by the trainer (Emma Jimenez Sanchez) of third place #7 "Pink Party Pants" (Santo Sanjur) alleging interference by the rider of second place #10 "Blazingly" (Yarmarie Correa) near the 3/8 pole. After reviewing the race replay of both incidents and interviewing the riders of #7 and #10, the stewards made the following determinations: There was no evidence of interference to cause the rider of #5 to clip heels and be unseated while in tight quarters. No action was taken. #5 ran with the field and was caught by the outriders after the race without incident. Jockey Fuentes was transported to the hospital. It was later reported that he had suffered an injury, but was released.

There was no evidence of interference by #10 to cause #7 to also clip heels while in tight quarters going into the turn. No action was taken.

Voided 2 claims - submitted by same stable for a single horse

A Stewards Inquiry was posted involving three horses near the 3/16 pole. Because no horse involved in the inquiry had finished in the top four, the race was posted official. After reviewing the race replay and interviewing the riders of #2 "Palmisano" (Mitchell Murrill) and #3 "Jack the Bird" (Alberto Burgos) the stewards determined that a chain reaction caused by an equipment malfunction had caused #3 on the outside to angle in, causing #2 to steady and #3 "Solidified Gold" (Santo Sanjur) on the inside to clip heels, hit the rail and lose all chance. Due to the nature of the incident and the placing of the horses, no action was taken.

5th RACE The claim of #11 "Ana" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
