1<sup>st</sup> RACE Voided claim - owner name misspelled

2<sup>nd</sup> RACE #1 "Kendal Grace" (Angel Serpa) was a late scratch from the post parade on the advice of the KHRGC veterinarian.

The claim of #2 "Filly Crystal" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

An objection was lodged by the rider of second place #8 "Mariposa de Pista" (Andres Calleja) alleging interference by the rider of the unofficial winner #10 "Razzle Red" (Yarmarie Correa) leaving the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.


