1st RACE A Stewards' Inquiry was posted involving an incident near the 6 1/2 pole. #3 "Rhubarb Martini" (Joseph Talamo) was in tight quarters and appeared to clip heels, unseating Talamo. The stewards reviewed the race replay and interviewed the riders of fifth place #2 "J Hertz" (Edgar Morales), second place #6 "Iggy Bigs" (John McKee) and Talamo. As there was insufficient evidence to determine the cause of the incident, no action was taken and the race was posted official. The horse ran with the field and was caught by the outrider.Talamo escaped injury.

- 2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.
- 3rd RACE #1 "Bright Venezuelan" (Joseph Rocco, Jr.) was a late scratch from the post parade on the advice of the KHRC veterinarian.
- 4th RACE An objection was lodged by the rider of fourth place #1 "Top Hat Boss" (Luan Machado) alleging interference by the rider of second place #9 "Keep Scrolling" (Ferrin Peterson) in the stretch. After reviewing the race replay and interviewing the riders, the stewards deterimined that there was no interference and the race was posted official.
- 5th RACE #4 "Edgee Angel" (Albon Jimenez) was a late scratch from the post parade on the advice of the KHRC veterinarian.
