#### **INCIDENTS/INQUIRIES/OBJECTIONS**

- Race 2 → The Judges had an injury on #4 Rocknroll Dakota to determine if going inside "1" Pylon gave #4 Rocknroll Dakota an advantage. After group discussion the Board of Judges unanimously agreed that #4 Rocknroll Dakota gained no advantage and allowed the race to go Official.
- Race 5 → There was a slight delay to the start of Race #5 due to #1 Caught Ina Scandal being a late scratch on the advice of the State Veterinarian concerning the horse bleeding from the nostrils. #1 Caught Ina Scandal will

be placed on the Vets List.

- Race 5 → #8 Noble Nadia was placed on the Judges List Break Off Qualifier
- Race 5 → #10 Dancing Dover was placed on the Judges List 3 Consecutive Breaks
- Race 9 → Driver of #4 filed an objection on the Driver of #5 declaring that his wheel was struck and flattened prior to the ½ mile marker. After clear evidence on film the Board of Judges unanimously agreed that a placing was warranted. #4 Scrappy Cominup was 3p2 and #5 Rollin Dice was 2p3 and the race was allowed to go Official with a new order of finish.
